Job Descriptions and Wage Scales

This document is designed to give guidance to churches, schools and ministries of the Northern California Conference in establishing wages and calculating budgets. We have a spiritual imperative and a legal requirement to treat our employees fairly. We must pay employees of the same class based upon the same wage scale and offer them the same benefits. This information will allow you to accomplish these goals. The Human Resources and Payroll Departments at the conference office will do the final calculations so use this as only a guide.

Steps to establish a Job Description and Wage Scale

1. Look on the Human Resources Department website to locate a sample job description that seems to match the job you need filled.
2. If you don't find an appropriate sample job description that contains the primary job functions you need, contact the Human Resources Department and we will work to provide a sample that matches.
3. Edit the sample to meet the needs and requirements of your ministry.
4. Submit the job description to the Human Resources Department to be reviewed by the Wage Scale/Job Description Committee.
5. The Wage Scale/Job Description Committee will assign a wage scale and approve the job description.
6. The job description and wage scale will be returned to you.

Matching a Job Description to a Wage Scale

1. Look at the list of Churches and Schools to find the cost of living number associated with your area.
2. Look at the job title list to find the corresponding letter code.
3. Find the page matching the cost of living area for your church, school or ministry.
4. Match the letter code for the job title on the page matching your cost of living area.
5. This will show you the six step wage scale for you to use.

Determining Which Step

Each wage scale has six steps. This is based upon the wage scale system used by the Seventh-day Adventist Church. The church does not follow the business standard of remuneration, but instead uses this system that is based upon the missionary nature of our work. This is the most subjective part of the wage scale process. The six steps are based upon education and experience. Usually a person just out of school, at whatever level required for the job, begins at step one. Each year thereafter, they are granted a one step increase, maxing out after five years.

Effective January 1, 2019 all locally funded employee wages will automatically be updated according to the NCC Locally Funded Wage Scale step they are currently assigned. Changes to pay rates not affected by the required California Minimum Wage

increase or NCC Locally Funded Wage Scale increase may be done by submitting a Change Personnel Action Request (PAR).

Hourly versus Salaried

This booklet is primarily about determining wages and not about employment practices. Those are available in the Employment Guidelines booklet and on the Human Resources section of the Northern California Conference website. In general you will only need the hourly amounts that are listed in this book. However, you will note that there are monthly amounts listed in the wage scale. Those are primarily there to help with budgeting. The one area where a salary is appropriate as listed in this booklet is with regard to Bible instructors and locally funded pastors. Because of special laws, they can be paid a monthly salary based upon this wage scale. It is very rare that anyone else will qualify to be paid a salary under employment law. If you have questions about this, contact Human Resources for more information.

Estimating the Cost of an Employee

There are many costs associated with employing a person. Some of those costs are dependent upon the hours worked, some are based upon job status, while others are event based. For instance, certain jobs require state mandated training on a regular basis. Below is guidance to assist you in estimating the cost to your organization for an employee. Remember that full-time employment is 38 hours per week or more.

Medical Coverage

All full-time regular status employees are required to be covered by our medical plan on their date of hire. Additionally, any employee scheduled to work 30 hours a week will also be eligible for health care. Employees can choose to opt out of our plans if they have other coverage, but they must sign a waiver. We offer two options with differing costs that are based upon who is covered. When covering dependents, whether spouse and/or child(ren), eligibility rules are considered. These rules are provided to the employee by Human Resources. It is very important to note that you cannot make employment decisions based upon a person's marital status or whether they have children, as that is discriminatory practice. It is best to budget on the maximum cost.

In addition, Medical Catastrophic Insurance is \$158 per month per employee covered by the Health Care Assistance Plan regardless of whether their dependents are covered or not.

Retirement

All regular status employees working half-time or more (currently half-time is 19 hours) must be granted participation in the North American Division Retirement plan. This is a 403(b) retirement plan. The cost to the employing entity is 5% of wages for the basic part and up to a 3% match. For budget purposes you should count on the full 8%.

Social Security Taxes

The employing entity pays the 7.65% Social Security Tax on all employees.

Long-term Disability Insurance

The employing entity pays the 0.38% of wages for Long-term Disability coverage for all full-time employees.

Basic Group Life Insurance

The employing entity pays for Basic Group Life coverage for all regular status full-time employees. The rates average about \$14.15 per month.

Workers' Compensation Insurance

The cost of Workers' Compensation Insurance depends upon the job being performed. The rates vary from \$0.79 per \$100 of wages up to \$19.22 per \$100 of wages. Most Church and School employees fall in the range of \$1-\$3 per \$100 of wages. However, check with HR or Payroll to find the rate for a specific job.

Vacation and Sick Leave Accrual

Employees working half-time or more in regular status positions are eligible for vacation and sick leave accrual according to policy. For budget purposes, use 11% of wages to estimate the cost of that benefit. Regular employees working less than half time, and temporary employees accrue one hour of paid sick leave for every 30 hours worked.

Tuition Assistance

All regular full-time exempt employees receive tuition assistance for their children. The entire cost will be billed to the employing entity. The cost of this assistance is hard to estimate because it is based upon the tuition charged by the school and whether or not the student is living at home or at the school. Review the assistance policy and contact the schools involved to calculate costs.

Bonuses, Farewell Gifts, and Holiday Gifts

Bonuses and gifts must be granted by a system and not capriciously. Remember, all employees must be treated the same. If you give a gift to one, then all NCC employees must be given the same gift for the same reasons. Therefore, no bonuses or gifts can be paid outside of those established by policy. Contact treasury for questions on what can and cannot be paid by policy.

Other Miscellaneous Costs

Some employees will be required to take certain government required training. Those costs can vary but we work with an organization that provides online training for most if not all those courses at about \$15 per year.

It is possible that employees may be required to attend meetings such as employee orientation, retirement seminars, etc. If that occurs, your organization is required by law to cover all such expenses the employee may incur such as travel, lodging, meals and incidentals. If there are costs of the training itself, the organization may be billed directly.
